RSRDCC Limited (Formerly RSBCC Ltd.).

Sir,

In continuation of this Department sanction of even No. dated 04.10.79, 9.12.81, 10.8.84, 17.10.87, 21.4.89, 13.02.90, 06.08.93, 28.11.94, 06.01.96, 26.08.96, 23.03.99, 07.01.2002, 17.05.2002, 02.04.2004, 16.07.2005 and in part supersession to last order dated 16.07.2005, I am directed to convey sanction of the Governor to the extension of the period for awarding of contracts for Civil Engineering works to the Rajasthan State Road Development & Construction Corporation Limited (Formerly RSBCC Ltd.) Jaipur upto 31.03.2008, subject to following condition :

1. The works by the Works Departments are being got executed by open tendering process and RSRDCC Limited Jaipur does not take part in these tenders so there is no need for relaxation in Rule 336 (b) of PWF&AR.

2. The Departments which are Non Works Departments, may get the works executed through RSRDCC Limited, Jaipur as per Rule 242 of PWF&AR, for which payment to the Corporation can be made on the basis of actual costs plus over heads. The calculation of the overheads will be as under :

- (i) Where design and drawings are to be prepared by Rajasthan State Road Development & Construction Corporation Ltd. at their own level.....9%.
- (ii) Where design and drawings are supplied by the client department/organization .....7.50%.

The above mentioned extension of the period for awarding of contracts for Civil Engineering works is upto 31.03.2011.

However, RSRDC Ltd. should not take up petty works of purchase of furniture, furnishing etc. and payment be considered through P.W.D for Non Works Departments, if Controller of Demand is P.W.D.

There should be a 10% increase in the volume of works procured by RSRDCC by tender process every year. Report to this effect should be conveyed to Finance and Administration department by 31st March of each financial year. Failure to submit such report would result in automatic withdrawal of the extension prematurely.

This issue with the concurrence of Finance (Exp.III) Department vide their I. D. No. 1293 dated 31.07.2008.


